

**Minutes of Emergent meeting of Executive Committee of Sahiwal Chamber of
Commerce & Industry (2018-19) held on 28th November, 2018**

Emergent meeting of Executive Committee (2018-19) of Sahiwal Chamber of Commerce & Industry was held in Chamber's office on 28th November, 2018 at 3.00 pm. The following attended the meeting:-

The meeting was started with recitation of verses from Holy Quran by Mr. Muhammad Tariq Awan, Secretary General. Thereafter the proceedings of the meeting were formally started as per following 1 item agenda:-

1. "To streamline joint efforts of the Executive Committee for reconciliation in between M/s Sh. Muhammad Afzal, Jalil Ahmad Butt and Sh. Muhammad Faisal Ikram, Executive Members regarding recently developed conflict amongst them".

1. The President opened the discussion apprising the House that before convening this meeting, he made a telephonic call to Mr. Sheikh Muhammad Afzal and requested him to close this chapter once and for all as it is bringing bad name to the Chamber but he did not respond in positive terms rather stated that he would like to see the logical end of the issue. The President added that on his repeated requests to wind up the matter, Sheikh Muhammad Afzal finally asked for some time to reconsider it.

2. Mr. Muhammad Faisal Ikram disclosed that Mr. Imran Ahmad Shah, Member National Assembly is also trying to resolve the issue and hopefully it will be settled in due course of time. He also suggested that meanwhile the matter may be entrusted to the Reconciliation Committee comprising of the suitable and impartial members of the Chamber for thorough probe and whosoever is found guilty, his membership of the Chamber may be dispensed with.

3. Mr. Muhammad Ali, Vice President stated that every action has its reaction and hence he who has started the issue, is at fault and may therefore, be dealt with accordingly.

4. Sh. Javaid Rashid proposed that efforts should first be made to arrive at some reconciliatory end and in case of failure, drastic action needs be taken against the delinquents.

5. Mr. Shahzad Anjum opined that a Reconciliatory Committee was constituted once in the past which was headed by Mr. Saleem Abdullah. A likewise Committee may be constituted again to resolve the instant issue amicably.

6. Mr. Muhammad Tufail Anjum expressed his view point stating that none will appreciate whatever is being done by the honorable members of the Executive Committee of the Chamber and must be stopped forthwith. He endorsed the suggestion of the House to constitute a Reconciliation Committee for the sake of resolving the issue.

Finally the House unanimously constituted a Reconciliation Committee comprising of the following Members with a specific and unambiguous under noted mandate with the hope that Committee will submit a positive report as early as possible:-

The above Committee was given the following mandate:-

- i. To play effective role for reconciliation in between M/s Sh. Muhammad Afzal, Jalil Ahmad Butt and Sheikh Muhammad Faisal Ikram, Executive Members, SCCI regarding recently developed conflict amongst them;
- ii. To resolve the issue by all means so as to maintain good image of the Chamber

The meeting was then adjourned with a vote of thanks by the President.
